GENEVA ACADEMIC FOUNDATION PARTNERS WITH CFFRV

The Geneva Academic Foundation (GAF) is a non-profit organization that raises money each year to fund grants for the purchase of equipment, tools, programs and services for the teachers and classrooms throughout Geneva Community School District #304, as well as two annual scholarships for graduating seniors from Geneva High School. Since 1987, the role of GAF in Geneva has been to provide an ongoing bridge to academic enrichment for all students across all schools in the district. In 2017, GAF established four funds within the Community Foundation to support their various objectives:



- Geneva Academic Foundation Endowment Fund
- Geneva Academic Foundation Teacher Grants Fund
- Geneva Academic Foundation Scholarship Fund
- Geneva Academic Foundation Viking Voyage to Excellence Fund

GAF recently launched its "Viking Voyage to Excellence" campaign to support the GAF Endowment Fund, which will provide GAF with a sustainable and consistent funding source for annual grant requests from Geneva schools and teachers.

Donations of any amount to the Endowment Fund are appreciated, but donors at certain levels will be recognized with a brass emblem engraved with their name and donation level on a permanent model Viking Ship display in the main hall of Geneva High School.

SOUND FINANCIAL PLANNING

Careful estate planning is important to our family and to the charities we support. It is possible to provide for charity while protecting our hard-earned dollars for the future benefit of loved ones. We sincerely hope that the following gift planning techniques will prove helpful to you.

►► IRA CHARITABLE ROLLOVER:

Donors aged 70½ or older may transfer as much as \$100,000 a year from an IRA to a charity without having to include any of that transfer as part of their income. But to qualify, that transfer must be made directly from the IRA to charity, and the donor cannot claim a tax deduction for the gift. Please contact the Community Foundation for more information on transferring assets from your IRA.

►►► HIGHLY TAXED ASSETS:

When preparing an estate plan, it is preferable that charitable distributions be made from IRAs or other assets on which income tax will be due upon death. Distributions of such assets to charity are not taxed. These same assets bequeathed to heirs will incur income tax. When leaving a bequest to charity, consider distributions from highly taxed assets.

►►► FUNDING CHARITABLE REMAINDER TRUSTS:

If an individual has substantial funds in an IRA, he or she may wish to contribute a portion of the funds to create a charitable remainder trust. The charitable deduction helps to cover a portion of the income tax due, removes the asset from the estate and generates income in retirement. Upon death, the CRT would create a named fund for the donor and his or her family.

►►► APPRECIATED ASSETS:

If circumstances permit, individuals should donate appreciated assets when making charitable donations. The donor of such assets can deduct the full fair market value of the gift and avoid a capital gains tax on the appreciated amount of the securities.

►►► GIFTS OF REAL ESTATE:

There are advantages to gifting one's home to charity while reserving the right to live in the home until death. As with all estate planning, the rules are complicated and require the assistance of qualified legal advisors.

CELEBRATING OUR GRANTEES

The Community Foundation continues to celebrate its grant recipients through Grantee Recognition Ceremonies. These events recognize the local social service, health, education and arts agencies that receive discretionary grants from the Community Foundation for various capital projects.

The fall 2016 grantees were honored at a ceremony in January. Twelve local nonprofit agencies were recognized at the event, which was hosted by Water Street Studios in Batavia. In June, the Foundation held a ceremony for its nineteen spring 2017 grant recipients at Waterford Cancer Resource Center in Aurora. NEW FUNDS SUPPORT EDUCATION

The Swami Vivekananda Scholarship Fund was created by the City of Aurora's Indian American Community Outreach Advisory Board (IACOAB). IACOAB's mission is to embrace the heritage and contributions of Indian Americans while encouraging Indian Americans to increase their involvement in Aurora's growth. The scholarship helps college-bound high school seniors further their education in a field of their choice.

The West Aurora High School Class of 1967 Fund was created by the members of the Class of 1967 to commemorate their 50th Class Reunion. This fund supports the needs of West Aurora High School and the A+ Foundation. It honors those who have so positively impacted the Class of 1967, including parents, family members, teachers, coaches, administrators and the West Aurora community.

The Eric P. Whitaker Scholarship Fund was established by Eric P. Whitaker, who received support from the then-Aurora Foundation in 1974 to attend the University of Illinois at Champaign-Urbana. He seeks to support others from North Aurora who graduate from West Aurora High School to develop themselves as citizens and professionals through full-time higher education.

The Jane Filips McEnroe & Paula Filips Mode Scholarship Fund was created by Rob Hollis to honor his mother Jane and her twin sister Paula. Jane and Paula attended West Aurora High School where they were known as the Filips Twins. When their father passed away, a family friend supported their education so they could attend Northern Illinois University. This scholarship fund helps other graduates of West Aurora High School to further their education.
